

LICENSE MINIMUM TERMS

Terms used but not defined herein shall have the meaning set forth in the Partner Agreement.

License Grant. End User is granted a limited non-sublicensable, non-transferable, and non-exclusive license to use the FlowX.AI Products and Services solely for End User's internal business purposes and in accordance with the Documentation for the applicable term provided in the End User Order Form. End User may make copies of the Documentation solely for End User's internal use. The FlowX.AI Products and Services are for use by End User, and only for End User's internal business purposes, and not for resale or sub-licensing to any third party.

Support and Services. FlowX.AI's sole obligation for Support Services and End User's sole means of support for the licensed FlowX.AI Products and Services are as set forth at [.....].

License Exclusions. End User will not, nor permit anyone else to: (i) copy, modify, sub-license, resell or distribute (or otherwise make available to or use for the benefit of others) the FlowX.AI Products and Services ; (ii) reverse engineer, disassemble, decompile or otherwise attempt to discover the source code, algorithms or structure, sequence and organization of the FlowX.AI Products and Services (including the FlowX.AI Products and third party); (iii) rent, lease, or otherwise use the FlowX.AI Products and Services on behalf of any third party; (iv) use the FlowX.AI Products and Services for performing comparisons or other benchmarking activities; (v) disrupt the integrity or performance of, the FlowX.AI Products and Services or the data contained therein or access the FlowX.AI Products and Services for the purpose of building a competitive product or service or copying its features or user interface, or (vi) use any component of the FlowX.AI Products and Services for which fees have not been fully paid or otherwise except as expressly licensed to such End User.

Confidentiality. “**Confidential Information**” means information, in any form or format, whether or not marked as confidential, identified as Confidential Information at the time of disclosure if disclosed in intangible form or the nature of the information and the manner of disclosure are such that a reasonable person would understand it to be confidential. End User will observe the Confidential Information related to the FlowX.AI Products and Services. Each Party will observe the Confidential Information of the other Party.

Communications. End User agrees they will become a public reference upon signing of a license agreement for FlowX.AI Products and Services and Partner and/or FlowX.AI and/or any or their Affiliates may communicate publicly about the project, and/or about the End User, and/or the FlowX.AI Products and Services provided to the End User under a license agreement, excluding any Confidential Information, following a general PR communication frame agreed with the End User. End User will publicly endorse positively any such communication.
